



DECISION OF THE PUBLIC AUTHORITIES BOARD OF THE ECSEL JOINT UNDERTAKING

Adopting the selection of project proposals retained for funding following ECSEL Call 2020-4 and the allocation of funding

THE PUBLIC AUTHORITIES BOARD OF THE ECSEL JOINT UNDERTAKING,

Having regard to the Statutes annexed to Council Regulation (EU) No 561/2014 of 6 May 2014 on the establishment of the ECSEL Joint Undertaking, and in particular Articles 9§5(b) and 12(e);

Having regard to the Decision of the Public Authorities Board on the evaluation and selection procedures related to Calls for proposals¹,

Having regard to the Governing Board decision approving the Work plan for 2020 and describing the scope and budget of ECSEL Call 2020-4,

WHEREAS:

- (1) Pursuant to the work plan for 2020, the Joint Undertaking has published on 05 February 2020, the ECSEL Call 2020-4, CSA Digital Excellence support action with a deadline of 05 May 2020;
- (2) Two Full Project Proposals were submitted in response to this Call, both proposals were assigned to independent experts for evaluation in accordance with the ECSEL evaluation and selection procedures related to Calls for proposals, under the coordination of the ECSEL JU;
- (3) Following the evaluation of the two full project proposals, the following results are reported in the Evaluation Report:
 - One proposal (SC3) fully satisfied the admissibility and eligibility criteria and was evaluated as being “above threshold”, the Evaluation Summary Report (ESR) was produced;

- One proposal (TySaSS) did not fully satisfy the admissibility and eligibility criteria, being assessed by the experts as “out of scope”. The H2020 procedure for “out of scope” proposals (Vademecum – Section 4 Grant Proposals) was applied and the proposal declared ineligible. No Evaluation Summary Report (ESR) was produced;
- (4) The PAB should approve the selection of the proposal declared eligible and above the threshold (SC3) with eventual indications of maximum eligible costs and allocated maximum public funding;
 - (5) The Executive Director should implement the decision of the PAB by entering into contact with the consortium of selected proposal and signing the relevant grant agreements.

HAS ADOPTED THIS DECISION:

Article 1

The “SC3” proposal shall be selected for possible financing within the maximum public funding allocated as annexed to this Decision (Annex 1).

The Executive Director shall take the necessary measures to implement the decision of the PAB and shall sign the grant agreement with the selected consortium indicated in Annex 2.


He shall inform the PAB of the date and conditions of the signature of the JU grant agreement.

Article 2

This Decision shall enter into force on the date of its adoption.
